## Privacy Policy:

### Privacy Statement

Thanks for visiting the website of the Academy for Musical Excellence. The Academy for Musical Excellence understands that the privacy of its users is important. Information collected on <https://amecindia.com> is kept private and never shared with other organizations. We're making this privacy statement to inform you about the types of information gathered and disseminated on the website. Please note that this policy has been developed with the recognition that Internet technologies continue to develop and evolve rapidly and that such changes may require us to alter our Privacy Policy. Any such alterations will not affect our general commitment to the protection of our visitors' privacy.

### General Statement

You may visit our website without identifying yourself or revealing any personal information. However, certain transactions that you choose to engage in on this site will require submission of your personal information, including, but not limited to, profile updates, applications and certain databases. As a general rule, the Academy for Musical Excellence will not sell, swap, rent, or otherwise disclose to any third party any such personal information for commercial purposes. Such information will be utilized only for the purpose stated. To accomplish such purpose, the Academy for Musical Excellence may disclose the information to its employees, consultants and agents who have a legitimate need to know the information.

### Use of Information

When you connect to our website, our web server may record the numerical internet protocol (IP) address of the computer or mobile you are using, information about your browser and operating system, date and time of access and the internet address and page which linked you to our site. The institute's staff uses such information to help diagnose problems with our server, administer and improve our website and generate aggregate statistical reports that analyse general user information and demographics. Such extrapolations and statistics may be made public; however, they cannot be tracked by individual users. Unless required by legal process, we do not link IP addresses to anything personally identifiable. This means that user sessions may be tracked by IP address, but a user's identity remains anonymous. In addition, we ordinarily do not disclose to third parties site usage by individual IP addresses but may do so in very limited circumstances when complying with law or legal process, working with consultants assisting us in fixing or improving our site, or in monitoring and improving the security of our network. Our staff monitors search terms that users enter into our search engine, but this tracking is never associated with individual users.

**Cookies**

Cookies are unique bits of computer data that many major websites will transfer to your computer on your first visit to the website. Cookies are stored on your hard drive and may later accessed by the website to track prior usage. The Academy for Musical Excellence uses cookies for multiple purposes, including authentication. You may block cookies by reconfiguring the appropriate settings in your web browser. Doing so may, however, restrict access to certain parts of the website. Cookies can also be removed from the user's hard drive whenever he wishes through his browser options. Information collected through cookies cannot be traced back to the user as it contains no personally identifiable data like name, address or phone number.
